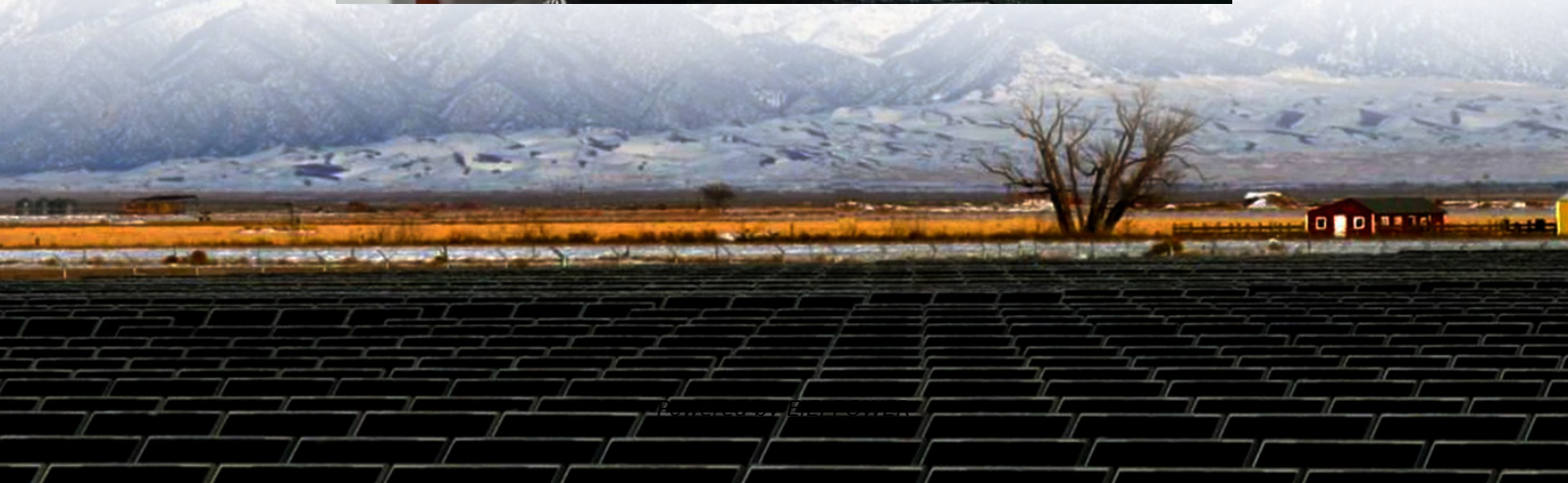
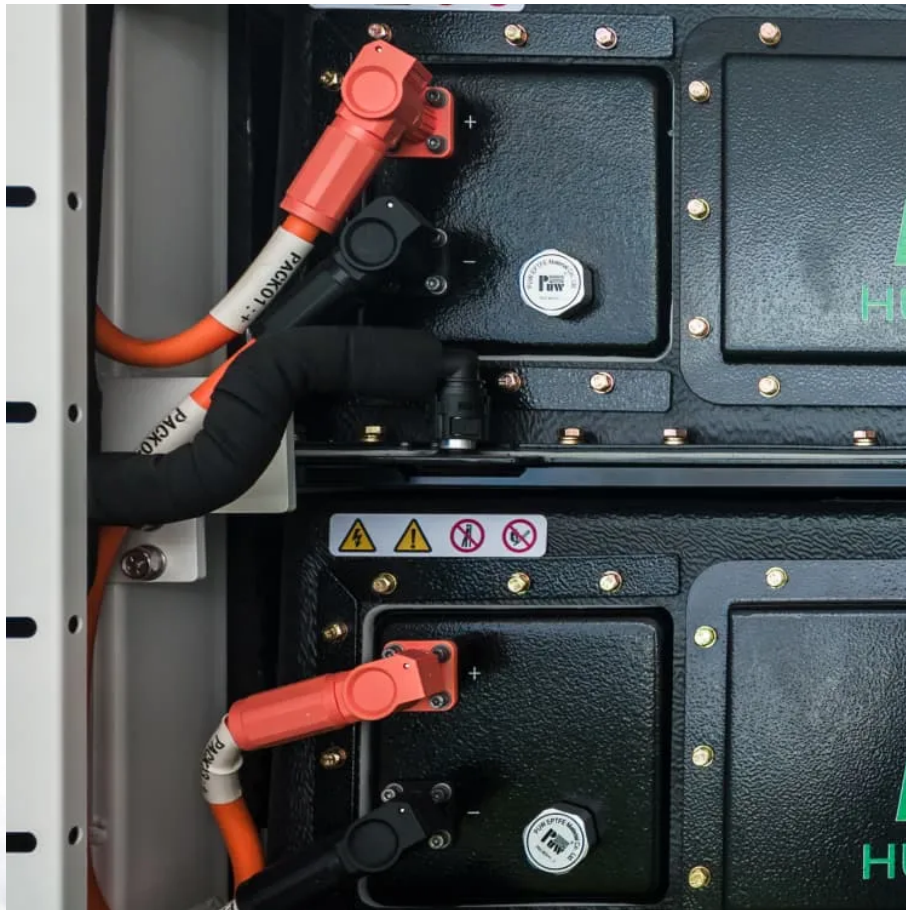


# Does the Netherlands use lithium for energy storage batteries

What is the lithium-ion rechargeable battery market in the Netherlands?

The lithium-ion rechargeable battery market in the Netherlands is a dynamic arena, brimming with both opportunities and challenges. Thanks to their superior capacity-to-weight ratio, lithium-ion batteries are outpacing other technologies in popularity.

When can lithium-ion batteries be stored?

When the storage of lithium-ion batteries exceeds 10,000 kg, it falls under the Decree on External Safety Establishments (Bevi). Although the PGS 37 directive provides specific regulations for the storage of lithium-ion batteries, Bevi remains applicable for large quantities of storage.

What are the transport rules for lithium-ion batteries in the Netherlands?

The following rules apply to the transport of lithium-ion batteries within the Netherlands: ADR: ADR (Accord européen relatif au transport international des marchandises dangereuses par route): Transport must comply with this European regulation, with specific requirements for packaging, labeling, and documentation.

When will battery storage be available in the Netherlands?

April 2024: The government of the Netherlands has allocated USD 109 million in subsidies for the installation of battery storage alongside solar installations for the upcoming year. Set to commence in January 2025, the program will run until 2034. This funding is part of a broader USD 453 million subsidy package announced in 2023.

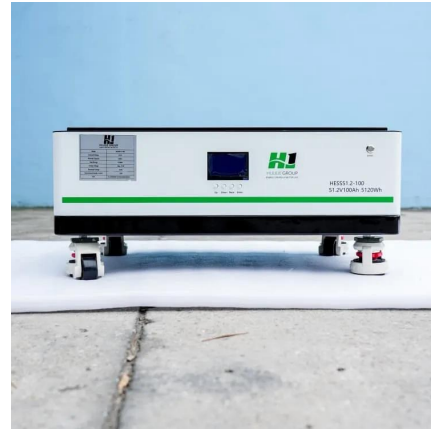
