At the early stages of sustainable development processes, information disclosure achieves an increase in the environmental regulatory intensity by regulating the cleaner production behaviors of enterprises. However, disclosure does not lead to the development of cleaner technologies or the improvement of green production efficiency.

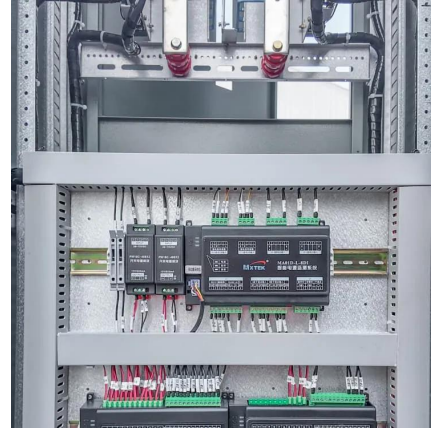
