

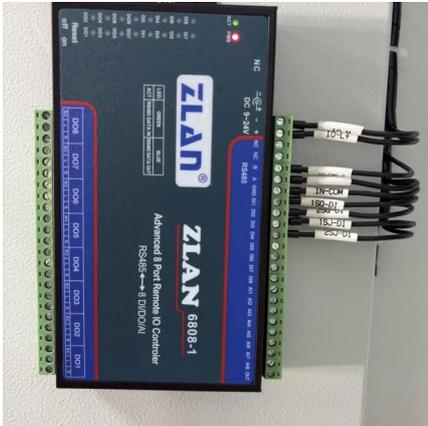

When will a standby charge be imposed on a solar PV installation?

In the Updated Guidelines, the EC has raised the threshold of the capacity of the solar PV installation for which the standby charge will be imposed. The imposition of charges is now only applicable to non-domestic installations with an installation capacity of 1MWp and above.


