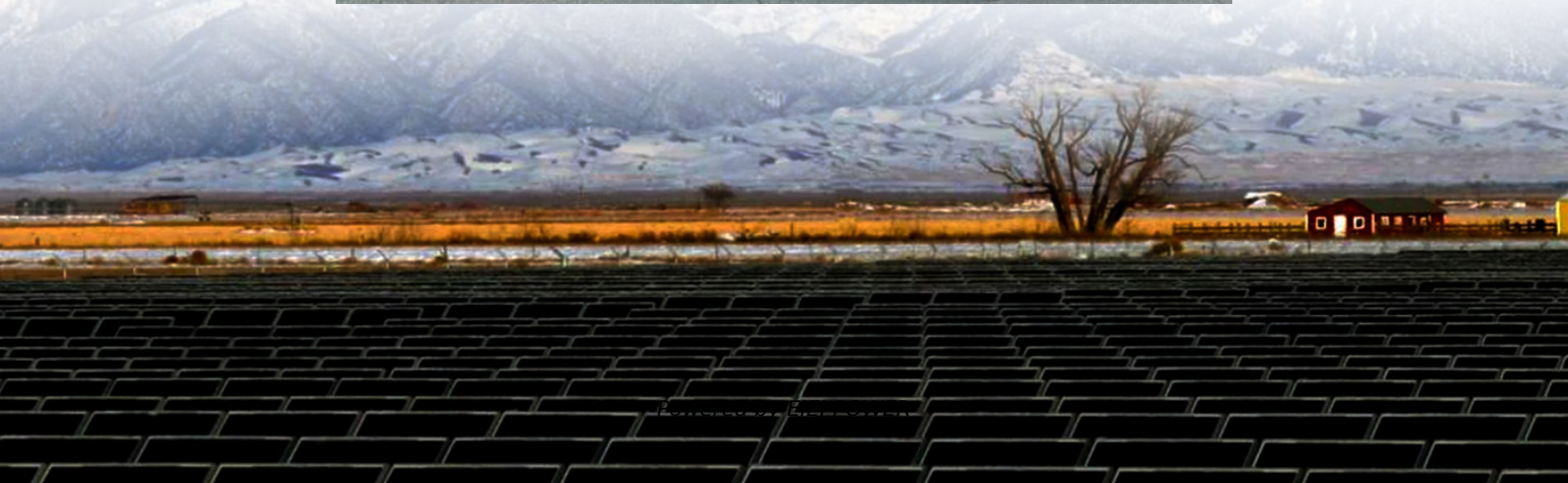


Settlement rules for the Mombasa Energy Storage Power Station in Kenya





Overview

What is net metering in Kenya?

Under net metering consumers feed excess electricity from their renewable captive sources into the grid, offering a cost-effective and sustainable energy solution. This mechanism enhances energy security and sustainability while diversifying Kenya's energy mix. The Energy (Net Metering) Regulations, 2024 were published in June 2024.

What is Kenya's Energy Policy?

This Policy encompasses all aspects of Kenya's energy sector, including electricity generation, transmission, and distribution; energy access, renewable energy resources, bioenergy and clean cooking solutions; energy efficiency and environmental sustainability.

What is system operations in Kenya?

System Operations is a critical function in Kenya's electricity sector. It involves the management of electricity transmission, coordination of power generation and balancing supply with demand using economic merit order of dispatch. Its role is to ensure that the national power grid is stable, reliable and efficient.

How has Kenya's electricity distribution system changed over the years?

Kenya's electricity distribution system has expanded over the years, to meet the Government's objective of universal electricity access by 2030. The expansion of the distribution system with inadequate reinforcement has constrained supply reliable and quality electricity to customers.

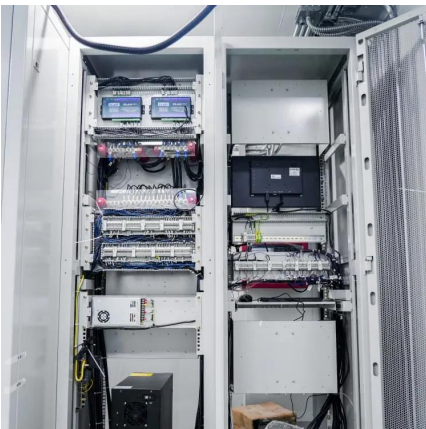

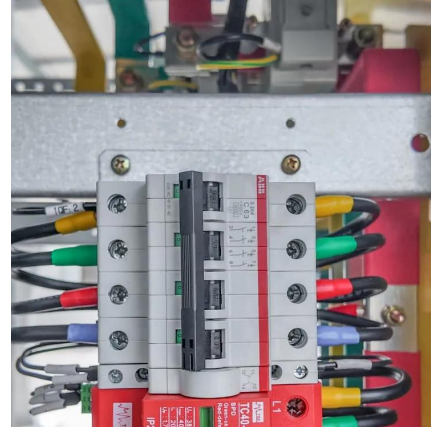
