Tariffs imposed by Solomon Islands in 2018 are below. The maximum rate of tariff in percentage on any product is 3,000. The simple average tariff across all products is 12.24. The trade weighted average tariff is 30.28. The total duty free imports in thousands of US dollars are 74,588.49 and duty free tariff line items share is 8.51.

Solomon Islands imports from Australia worth US\$ 110 million, with a partner share of 18.22 percent. Solomon Islands imports from Singapore worth US\$ 98 million, with a partner share of 16.27 percent. Solomon Islands imports from China worth US\$ 89 million, with a partner share of 14.87 percent.

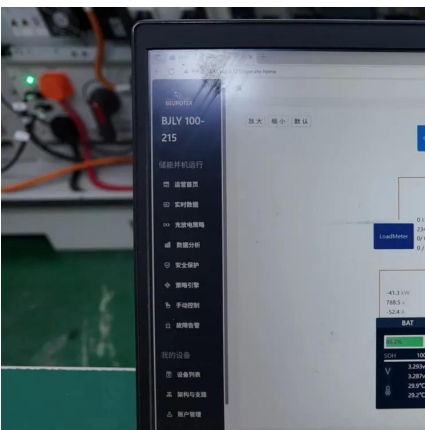

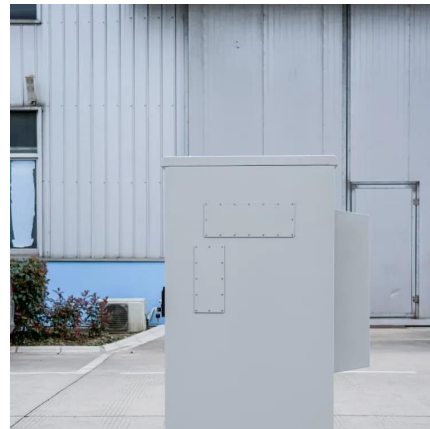
