Which countries import the most solar modules?

Brazil accounted for 68% of the region's total imports, followed by Chile at 7%, with imports totaling 2.48 GW of modules. The Middle East imported 1.97 GW of modules from China in December 2024, up 16% MoM from 1.7 GW and up 31% YoY from 1.5 GW. China exported 5.9 GW of modules to the Middle East in 4Q24, up 42 % YoY from 4.15 GW.

Who are the top 20 global photovoltaic module manufacturers?

During the conference, PVBL announced its annual ranking of the top 20 global photovoltaic module manufacturers. In 2024, the global solar module market continued to see the strongest players thrive, with the top four enterprises — JinkoSolar, LONGi, Trina Solar and JA Solar — collectively shipping over 320GW and dominating the industry.

Which countries export solar panels?

China is the world's leading exporter of solar panels and related devices. It accounts for about half of the global market. Malaysia, Vietnam, South Korea, and Thailand are also major exporters of solar panels. According to the solar panel import data, these are the top importers of solar panels and related devices:.

Which country exports solar panels in 2022 - 2023?

India is a major exporter of solar modules. The export market for Indian solar modules in 2022-2023 saw a whopping 364% increase from the previous year. Based on Solar Panels Export Data, the total value of exports was INR 8,440 crore (around \$1.03 billion), with the United States being the top destination with a 97% share.

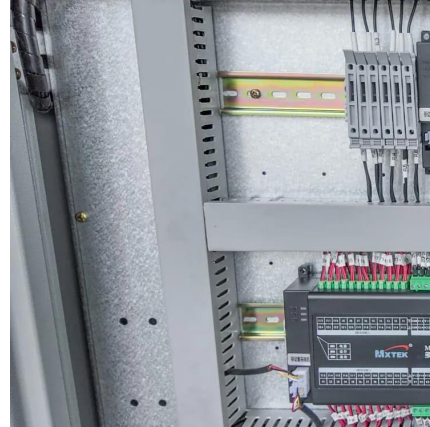

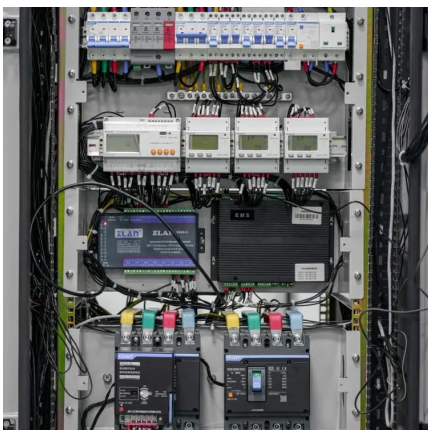
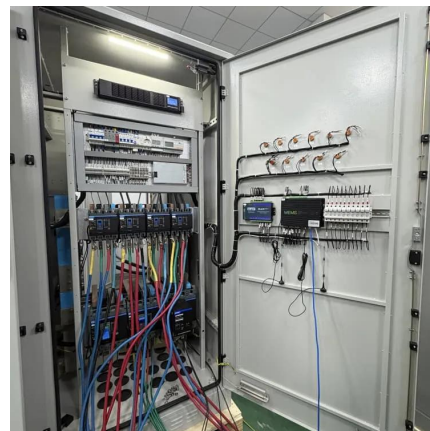
